Items a and c were approved 8-0. Item b was then brought of floor by Alderwoman Johnson. Alderman Kreinbrink made a motion to approve item b after changing amount to \$325,529.95. Motion carried 7-1.

Mayor's Report:

a. Mayor Latham asked the council for acceptance of his quote to Advanced Asphalt of Princeton for \$99,365. Before vote City Administrator reported that he had gotten amount changed to \$91,942. Motion made by Alderman Robinson to approve, 2nded by Alderman Kreinbrink. Motion carried 8-0.

- b. Bid by Landmark Contractors Inc. of Huntley, IL was rejected for Griswold Springs Culvert Replacement. Geoff Penman said price brought down slightly to \$100,416.80. Will be addressed at a later time.
- c. Mr. Penman reported on Dental Rate Increase that it had gone up by about 6% from last year. About a 2% increase from last years rate. Council voted to accept, motion made by Alderman Whitecotton and seconded by Alderwoman Killey. Carried 8-0 by council.
