The Filter media and tank asm was rebuilt and painted inside, new rock and sand, Anthracite was added, the media will also accommodate the new HMO system when we decide to install the system,

A Radio study was done for communication research proposes for Both water plants and both EWT at green street and Duvick Ave. cost of FCC Lic \$1000.00 every 10 years cost of \$100.00 per year verse currently we Budget \$4400.00 a year once our system is up and operational we will save approximately \$4000.00 annually, looking at starting stage one of SCADA with this system, starting with \$5000.00 for parts this year, and complete the install in 2022/2023 budget, total price \$147,000 from TRI R, we will be able to remote access the system with phones or laptop, cutting down on possible OT hours, clearing alarms at home.

Gasvoda came in over 150K

We performed a 6 week pilot study for the use of HMO for emergency well # 3 (مالمارة) that will aid in radium removal, new projected cost for a automated system is \$316,440.00 EEI and bid out company to install, could come in lower.

Brian Voelkel

- There is no material inventory required to be submitted to the Illinois EPA by April 15, 2022.
- The initial material inventory is required to be electronically submitted by <u>April 15, 2023</u>.
- The FINAL complete material inventory is due no later than <u>April 15, 2024</u>. It shall include the compositon of all service lines in the community water supply's distribution system.
 - 415 ILCS 5/17.12 redefined Service Line to mean the piping, tubing, and necessary appurtenances acting as a conduit from the water main or source of potable water supply to the building plumbing at the first shut-off valve or 18 inches inside the building.

100 section water meters accounts

Manual read meters: 353 Manual meters \$86,838

Radio meters: 566 radio meters

919 total water meters in this section

Cost to replace a water meter and radio unit is \$246, the cost just to install a radio unit is \$191.00

To replace the manual reads to radio unit will cost \$86,838.00

200 section water meter accounts

Manual read meters: 566 Manual meters -117TP \$110,454.00

Radio meters: 573 radio meters

Out of the 566 manual readers, 117 are touch pad, will only require a radio unit, \$ 22,347.00

300 section water meter accounts

Manual read meters: 359 \$88,314.00

Radio meters: 552 radio meters

Total cost to update all regular reader to radio including touchpad readers, \$285,606.00

This option would save manpower hours having drive by units. Currently the city has 3 people that read water meters, approximately 225-man hours are use in one year to read water meters. 3 sections of town are read quarterly, typically each section takes 2 day except 200 section takes 2.5 days 2 personal from streets, and 1 from water department.
